The New Jersey State Elks Association, which is now in its 112th year of service to our State, is comprised of 107 hardworking and dedicated Elks Lodges. Our current membership is over 57,300 members.

All monies have been receipted and forwarded to Treasurer Ken Low for deposit and all requests for payment have been reviewed for completeness, vouchered, and submitted for payment. The State Association received \$1,877.37. This represents pro-rated dues for new members and reinstatements for the first 6 months of the Lodge year.

State Chairmen are reminded that a blank voucher is available for download on the State Secretary's page on njelks.org. All requests for payment must be submitted with a completed voucher and receipts attached.

This is very important: Exalted Rulers are asked to remind their Lodge Secretaries that a member's highest title should be indicated on the Contact Page of their record in CLMS in the "Elk Title" box. This information is used for data sorting purposes when voting lists are prepared, State Association Cards are printed, and verification of names for the Annual Memorial Service.

On behalf of our State Treasurer, I would like to thank everyone for ensuring that all checks made out to the association are made payable to NJSEA and use the memo line for committee designation.

On Sunday March 1, 2026, the Association will be holding its annual elections. Resolutions have been received from PDD Don Tonachio, Lacey Lodge #2518, and PDD Rich Poole, Brigantine Lodge #2428 for the position of State President. There was one resolution for the position of State Secretary – Sue Dupas, PDD Cedar Grove Lodge #2237; and one resolution for the position of State Treasurer - Kenneth Low, PDD Elmwood Park-Paterson Lodge #60. The positions of State Secretary and State Treasurer are uncontested.

"New Jersey Elks Compassionate, Touching Lives and Changing Tomorrows" Any qualified member interested in running for District Vice President should have their resolution submitted to myself, their District Vice President, and State President Bill Dow, Jr., no sooner than December 1, 2025, and no later than January 5, 2026. The resolutions must be sent via Certified Mail, return receipt requested or by email. Any resolutions that are not in compliance with the State By-laws will not be accepted and returned for re-submission.

There will also be elections for State Trustee in the East, Northeast, South, and West Central Districts. The rule for submission of resolutions is the same as Vice President.

Current Vice Presidents are requested to contact Past Special Deputy Grand Exalted Ruler Francis J. Decibus to confirm the location of their district's voting location. The State Association will be mailing postcards to all eligible voters, based on the list updated January 2026.

The first State meeting was held on August 5, 2025, at Jamesburg Lodge #2180 and was well attended.

Each district received a complete copy of the GL Essay contest package including an intro letter from GL Administrator; Summary of the Contest rules; Essay Cover Sheet and the Contest summary sheet to be given to the student. This year's topic is "What Does Service to Your Country Mean to You?" The packet also included the Entry form for the NJSEA Americanism Challenge. We reviewed judging criteria for the Challenge which awards two \$500 prizes, to a lodge in each Region 1 and Region 2. We also discussed the difference between the Challenge and the All-American Lodge Contest.

Anticipated expenses and potential fundraising opportunities were discussed. Individual districts were encouraged to conduct events for donations to the state committee. We plan to run a Super 50/50 Raffle, but it has been delayed due to the slow response of the State in issuing the permit. The winner will be drawn on the March 8, 2026, Committee Meeting.

I have sent Half-Mast Flag notifications to Region Co-Chairs and all District Chairs when received.

I was able to attend the Flag Retirement ceremonies of two Districts.

The next meeting is a Zoom meeting scheduled for November 5, 2025, which has not taken place as of the writing of this report. The agenda includes review of Essay contest due dates and judging criteria and promotion of Americanism programs such as Fly the Flag recognition and the Americanism Challenge.

The final meeting, when we will judge essays for advancement to the Grand Lodge national contest and pick winners of the raffle, is scheduled on March 8, 2026, at Jamesburg Lodge #2180.

At this time, we have 14 lodges with an "out of balance" issue. We, as a team, will work to try and get all lodges back in balance.


We also have 5 lodges who are missing information. All District Coordinators are working to get this information submitted.

FALL CONFERENCE DRUG AWARENESS REPORT 2024

The Drug Awareness Committee is continuing to get the word out about our program. Many Districts and Local Lodges have participated in events partnered with their communities. Drug Awareness literature has been handed out at these events. More and more requests for literature for use in school programs have been received.

Our Drug Awareness Poster, Essay and Video Contests have begun. This year's theme is "Drugs are a Grave Mistake". Information has been sent to schools throughout the state. Our Poster Contest is open to students grades 3 through 5. Our essay contest is open to students grades 6 through 8, and our Video Contest is open to middle and high school students. The contests run through January 2026. State winners will be announced at the NJ State Convention in Wildwood where awards will be presented. Our contests play an important part in increasing awareness in our schools and to aid our students in making positive and healthy lifestyle choices.

Nominations for the Enrique Camarena Award are due to me by November 30, 2025. This prestigious award is presented to a member of the law enforcement community that goes above and beyond in their duties and dedication to drug awareness. At our Wildwood Convention last June, myself and my Advisors had the honor of awarding Corporal Jayme Higgins of the Howell Twp Police with the Enrique Camarena Award for the state of NJ. His nomination was submitted by Howell Lodge 2515.

As you are aware, the Walk Out on Drugs is the state's largest fundraiser for Path to Leadership and Peer Leadership. This year, all 12 districts have held a Walk Out on Drugs in one form or another. Walk Outs are to be held each year between April 1 and November 1. As of this report, total funds from our Walk Outs are \$42,339 with 9 Districts reporting. Once again, a shout out to the SED for raising \$12,600 this year. The funds raised at our Walk Outs are used to send students to the Path & Peer Conferences. Lodges who donate a minimum of \$1,000 can send one student for free. Support for our Walk Out is crucial for the continuance of our programs. In addition to the Walk Out on Drugs, Districts and Lodges throughout the state have been working all year holding various fund raisers for Drug Awareness and the Walk Out on Drugs.

The 7th Annual Gerry Cook Golf Out took place at the Farmstead Country Club in Lafayette on October 9th. \$10,000 was raised for Drug Awareness and Peer Leadership.

Our Path to Leadership and Peer Leadership Conferences will once again be held at the Ocean Place Resort and Spa in Long Branch, NJ. Our one day Path conference for Middle School students will be held on Thursday, February 5, 2026 and our 36th Peer Leadership Conference for High School Students will be held from February 6th thru the 8th, 2026. As of this report, we have received 170 applications for Peer and 50 for Path. Our Peer Leadership Committee works very long and hard during the year to ensure that our students have the best possible experience and education to choose the right path in life. Applications are available on line for both conferences on the State Website, Peer leadership Facebook and Instagram Pages. How to apply has been sent to all lodges, schools and municipal partners throughout the state. We are looking forward to another life changing conference in February 2026.

Since the 2025 Wildwood Convention, the NJSEA Historical Committee has continued its efforts to capture, document, and provide information and exhibits of the State Association and its history. Currently, the Committee shares this information primarily at the State Museum at Lacey Lodge #2518.

New exhibits of artifacts and images donated to the Committee are being prepared, such as a three foot long 1931 photograph of Newark Lodge #21 parade marchers. The photo was donated by Livingston Lodge #1855. In addition to the Committee's already existing inventory, even more artifacts, like two 1909 and 1921 Convention broach pins donated by State President Dow, are being received. All such new pieces will be catalogued and prepared for future display. An exhibit for the State project of Camp Moore (via TV monitor) shows now in the museum along with our Past State President display. Other boards or displays (i.e. - State Veterans Services history; NJ Lodge picture compilation) are also in the works.

The Committee investigation of "Elk Rests" within the state has been positive. It is now confirmed that there are Rests for Camden, Lakewood, Trenton, and Hoboken lodges, making a total of seven of these dedicated, special places within NJ where fellow Elks repose. The Committee hopes to foster or further the relationships of the cemeteries that contain an Elks Rest with their host lodge, or through NJSEA when the host lodge no longer exists. Additional graphics and boards for display, or posted online, about our NJ Rests are in development.

The State website pages of the Historical Committee were recently refreshed (July) and are current. Expanding our reach of historical exhibits is planned with future updates for the website.

At the recent Army of Hope event (Sept. 2025) the Committee estimates that upwards of 100 visitors came through the museum doors that day alone.

For Fall Conference 2025, the Committee will display boards of the Committee and museum.

Internet Operations Committee Fall Conference Report, 2025

The Internet Operations team has a lot of work to accomplish this year – to make it easier for district authors to update to the state website, to provide general refresh of njelks.org, and to upgrade the infrastructure to enable the running of the latest versions of our web software.

We had a district author meeting in early July to get everyone on the same page. This year we have six new district authors, so an overview of the responsibilities was in order. We had a good discussion and a productive training session. We will probably have two more of these meetings during the rest of the year.

I've met with the Region Co-chairs (Dan Boesman from Manahawkin #2340 and Louis Lusquinos from Nutley #1290) somewhat regularly over Zoom – to discuss both current issues and future plans. I've also learned a lot from them – particularly about how and why decisions have been made in the past – since they've been on the committee longer than I have. Many of our meetings involve the committee advisors – Bob Mauro of Red Bank #233 and Joyce Powell of Hasbrouck Heights #1962 – whose guidance, strategy, and advice is invaluable.

I have my wish list for the state website that I'm using as my to-do list:

- Self-serve password resets: users who have forgotten their password, should be able to easily reset it. Right now, the process involves too many steps.
- Upgrade versions of Joomla and PHP: the website runs on software called Joomla; we're running an outdated version of that software. I'd like to get it updated to a supported version. Likewise, the Joomla software uses the PHP scripting language, which is out of date. I want to get that software updated as well. One potential problem is that the update of Joomla might require a redesign of large sections of the website and one of the longer-term goals is to have the website redesigned so we might want to skip the updates and redesign the entire website sooner and skip upgrading Joomla on the existing site.
- Easier posting: the process of posting information on the website is not as easy as I feel it should be. Part of this is because of the older version of Joomla, so it's possible that this gets resolved by any upgrade or redesign. I'd also like to standardize the way that calendar posting of events is done across districts.
- Create policy and process on website account activation/deactivation: the process of creating user accounts on the state website is a manual process and typically happens by user request. I'd like the account creation process to occur in an automated manner based on an individual's role and responsibility for the current year. Similarly, we should be able to automatically deactivate a user's account when special access is no longer needed.
- Mobile-friendly: the current website is not mobile-friendly or optimized for access on the screens of a mobile phone. It's 2025 and smart phones are ubiquitous. The state website should be easily readable from a smart phone. Again, part of the issue is the older version of Joomla. An update or website redesign should remedy this issue.

The committee has a lot of work to do in the upcoming months, and not all changes will be immediately visible. But hopefully, everyone's experience on njelks.org will improve over the second half of the year.

REPORT OF LAWS COMMITTEE – November 15, 2025 By Robert F. Binetti, PGLC, PSP, State Chairman

Good Morning. There are three legal issues to bring to your attention this morning. First, supplementing the position on the possession of Marijuana on Elks property, addressed at the Annual Convention in Wildwood, I refer you to the letter sent by Tom Zisa to each Lodge. Some Lodges have asked if they can post a notice at the Lodge advising that possession of Marijuana on Elk owned property is not permitted under Federal and Elk Law, and after consultation with our Sponsor, you are advised that each Lodge is free to do so.

Second, you are reminded that each Lodge must have a general revision of their By-Laws and House Rules passed by the Lodge no later than the 5th year following the adoption of their latest By-Laws and House Rules, as required by Grand Lodge Statute 17.060.

Third, each Lodge must make sure that the Lodge complies with the requirement of Grand Lodge to have their IRS Tax Form 990 filed with Grand Lodge no later than August 1st, irrespective of the fact that the IRS allows it to be filed at a later date. The failure to do so will incur monetary penalties to the Lodge that fails to file by August 1st.

This completes my report on drugs, By-laws and taxes and I move for its adoption.

Dignities, and members all,

Here are the updates concerning the completion of the 2025-26 Scholarship season. The 2025 New Jersey State Elks Most Valuable Student Scholarship the top 90 applicates were award with checks of \$700 each and a congratulatory letter have been sent out to all the winners. The top two winners have also been sent their checks for \$1000. The eight winners of the New Jersey Elks Vocational Scholarship have also been sent their checks. 77 winners of the New Jersey Elks Family Scholarship have been identified and their congratulatory letters and \$900 award checks have been sent.

The student response in terms of applications received last year for all our scholarships, each district was well represented. Thank you to both our region chairs – Region 1 Karen Imperatrice & Region 2 Marguerite Aisenstock along with all the district and local lodges chairs.

The Elks National Foundation gives out over 2.5 million dollars in scholarships each year and the 2025-26 Scholarship season is now underway. The Most Valuable Student scholarship contest will close on Wednesday, November 12th (before fall conference). It was open to any high school senior who is a US Citizen. Applicants will be judged on academics, leadership, and financial need. Applications for the 2026 contest are available online at Elks.org. The student are able to choose which lodge will receive the application from a list of five which are closest to their home. There will be 500 four-year scholarships given out ranging from \$4000 (\$1000/year) to \$50000 (\$12,500/year). The top 24 applications from New Jersey will pass onto the national level of judging and will receive at least a \$4000 scholarship, the next 96 top applications from New Jersey will receive a onetime \$700 award from the New Jersey State Elks.

The Elks National Foundation Legacy Awards scholarship program offers 350 college scholarships worth \$4,000 each to the children and grandchildren of Elks members. Eligibility: College-bound high school seniors who are the children or grandchildren of dues-paying Elks

are welcome to apply. Applicants compete against other children and grandchildren from the state of their sponsoring Elks Lodge. They are judged on the core values of the Elks National Foundation: knowledge, charity, community service and integrity. Applications are available online at Elks.org and the deadline is February 7, 2026, at 11:59 a.m. Central Time. New Jersey families will be eligible for 10 awards. An addition 103 at-large scholarships will be awarded to the best-scoring applicants, regardless of state.

The 2026 New Jersey Elks Family Scholarships will be available to children, grandchildren, and greatgrandchildren (stepchildren, step-grandchildren and step-greatgrandchildren) of New Jersey Elks. The scholarships are open to high school seniors as well as college freshman, sophomores, and juniors. The contest will run from April 15, 2026, to June 30, 2026. Applications will be available online April 15, 2026, at NJElks.org. This year winners will be awarded \$900 each.

Also in review, the New Jersey Elks Vocational Scholarship is available to students within 4 years of graduating high school who are United States citizens that will be enrolling or are enrolled in an accredited vocational school or program. There will be 2 awards in each of our 12 districts throughout New Jersey. Applications will be available at schools throughout New Jersey as well as online at NJElks.org on March 1, 2026. Applications may be submitted from March 1, 2026, to May 15, 2026. Applications should be sent to the local Elks Lodge where the applicant resides.

We encourage Lodge Chairs to present the winners of any of the Elks Scholarships with a certificate at the student's high school awards nights. These presentations will showcase the winning student's accomplishments and the Elks Scholarship programs.

Our Scholarships programs not only help students with the cost of their education but get the Elks "brand" out into our communities. Elks Scholarship Programs can also be used as a valuable aid in cultivating new members.

NEW JERSEY STATE ELKS ASSOCIATION SPECIAL CHILDREN'S COMMITTEE BY-LAWS

Revised: September 12, 2022

and

Amended at: Fall Conference Date: November 12, 2022

ARTICLE 1 – OFFICERS

- **Sec.1. Place.** The New Jersey State Elks Association Special Children's Committee, hereinafter referred to as the Corporation, shall maintain a principal office within the State of New Jersey at such place as may be determined by motion at any meeting of the members.
- *Sec. 2. Other Places.* The Corporation may have other offices at such other places as may from time to time be determined by the Board of Trustees.

ARTICLE 2 – MEETINGS

- **Sec. 1. Annual Meeting.** The annual meeting of the Committee shall be held at the principal offices of the Corporation, or at such other place within the State of New Jersey as the State Chairperson may designate, on the third Sunday of October of each year. The Administrator shall notify each member not less than ten days before the meeting date.
- **Sec. 2.** Other than annual meetings, the Committee may be called at any time by the Chairperson of the Committee at such place within the State of New Jersey as they may designate.
- **Sec. 3. Quorum**. The presence in person of 30% of the Committee at the annual or any other meeting regularly called shall constitute a quorum for the transaction of business.
- Sec. 4. Voting The Committee eligible to vote shall consist of the State Chairperson, the five (5) Trustees, Recording Secretary, Treasurer, Region 1 and Region 2 Co-Chairpersons, twelve (12) District Chairpersons, Miracle on the Mountain Coordinator, Miracle on the Mountain Region 1 and Region 2 Coordinators, Miracle Run Liaison, Building & Maintenance Chairperson, Challenger Sports Program Coordinator, Challenger Sports Program Region 1 and Region 2 Coordinators. (Total of 30 Members). At all meetings of Members, a vote of the majority of the Members present shall be sufficient to decide all questions.
- Sec. 5. Meetings. The Committee shall meet monthly, at a time and place designated by the Chairperson, and at such other times as deemed necessary by the Chairperson, this includes meetings held electronically via Zoom or a similar platform when deemed necessary. Should any Member of the Committee absence themselves from any three (3) meetings without sending a communication to the Chairperson or Executive Secretary, noting the reason for absence, or for just cause during the New

Jersey State Elks Association Calendar Year (June – May), such Member may be removed from the Committee by the State President.

ARTICLE 3 – OFFICERS

- Sec. 1. Members. Members of the Corporation shall be those delegates or members of the New Jersey State Elks Association who are appointed members of the New Jersey State Elks Special Children's Committee by the President of the aforesaid Association. Such Delegates or Members thus appointed shall remain Members of the Corporation for one year or until a new State Elks Special Children's Committee is appointed, unless sooner relieved of such committee assignment by the President of the aforesaid Association.
- *Sec. 2. Officers.* The officers of the Corporation shall consist of a President designated as State Chairperson, Region 1 Co-Chairperson, Region 2 Co-Chairperson, Recording Secretary, Treasurer, and the Board of Trustees.
- **Sec. 3. Appointment.** All officers of the Corporation shall be appointed by the President of the New Jersey State Elks Association.
- **Sec. 4. Term.** The term of office of each of the officers shall be one year, and thereafter until their successor has been appointed.
- *Sec. 5. Vacancies.* Vacancies shall be filled for the unexpired portion of the term by appointment of the President of the New Jersey State Elks Association.
- **Sec. 6. Duties of Officers.** The duties and powers of the officers of the Corporation shall be as follows:

~ STATE CHAIRPERSON ~

The State Chairperson is the Executive Officer of the Corporation and shall preside at all State Committee Meetings.

- A. Shall present at each annual meeting of the members a report of the condition of the Corporation.
 - B. Shall call all regular and special meetings of the members in accordance with these By-Laws.
- C. Shall enforce these By-Laws and perform all the duties incident to the position and office, and which are required by law.
 - D. Shall be an ex-officio member of the Board of Trustees without vote.

~ CO-CHAIRPERSON ~

During the absence and/or inability of the State Chairperson to render and perform their duties or exercise their powers, as set forth in these By-Laws or in the acts under which this Corporation is organized, the same shall be performed and exercised by the Co-Chairpersons; and when so acting, they shall have all the powers and be subjected to all the responsibilities hereby given to or imposed upon such State Chairperson.

~ ADMINISTRATOR~

The Administrator shall be the custodian of the minutes from the meetings of the State Committee Meetings and from the meetings of the Board of Trustees in appropriate books.

- A. Shall give and serve all notices.
- B. Shall be custodian of the records.
- C. Shall attend to all correspondence and perform the entire duties incident to the office of the Administrator as determined by the Board of Trustees.

~ RECORDING SECRETARY ~

The duties of Recording Secretary are to record the minutes and correspondence from the State Committee Meeting and forward to the Administrator.

~ TREASURER ~

The Treasurer shall have the care and custody of and be responsible for all the funds and securities of the Corporation, and deposit all such funds in the name of the Corporation in such bank or banks, trust company or trust companies or insured savings and loan associations or savings and loan associations as the Trustees may designate.

They shall present all bills against the Corporation to the Board of Trustees and /or at the State Committee Meeting for approval/rejection. They shall disburse funds only upon approval of the Board of Trustees and/or by the voting committee at State Committee Meetings.

They shall render a statement of the condition of the finances of the Corporation at each regular meeting of the Board of Trustees and at the State Committee Meeting or at such other times as shall be required to provide a full financial report at the annual meeting of the members. They shall do and perform all duties pertaining to the office of Treasurer as determined by the Board of Trustees.

~Building and Maintenance Chairperson~

The Building and Maintenance Chairperson shall have the responsibility to oversee all new construction at the camp; solicit bids for construction projects; repair and replacement of equipment at the camp; ensure the camp is in proper state of repair. They shall submit all bids for construction, repair, or replacement at the camp to the Board of Trustees for approval.

~ MIRACLE ON THE MOUNTAIN FUND COORDINATOR ~

The Miracle on the Mountain Fund Coordinator shall receive all monies designated for the fund and deposit same with the Treasurer; keep all records of income and expenses to the fund; design and implement promotional programs to publicize and solicit funds and present bids for same to the Board of Trustees for approval; with the approval of the Board of Trustees, order all supplies needed to administer the fund; ensure invoices for yearly subscriptions are sent out in a timely fashion.

ARTICLE 4 – TRUSTEES

- **Sec. 1. Number and Appointment.** The affairs and business of this corporation shall be managed by a Board of Trustees composed of five (5) Members who shall be appointed by the President of the New Jersey State Elks Association, after considering the recommendations and advice of the State Chairperson and Advisors of the Committee.
- Sec. 2. Duties of the Board of Trustees. The property, affairs, business, and concerns of the Corporation shall be vested in the Board of Trustees. The Board shall control the investments, funds, real and personal property of the Corporation; execute all leases, contracts or other paper when ordered by the Corporation. The Board shall review and approve/reject all bills against the Corporation; present bills to the Committee for vote and payment of same; have the power to incur bills and disburse the funds of the Corporation; hire employees and agents, devise and carry into execution other measures as they may deem proper and expedient to protect and promote the interest of the Corporation. The Trustee Chairperson shall preside at all meetings of the Board of Trustees. The Board shall set all policies for the Corporation with the approval of the Committee.
- **Sec. 3. Term.** The term of office of the Trustees shall be one year through five years and thereafter until their successor has been appointed. The initial Board of Trustees appointed under this provision shall be appointed for a one-, two-, three-, four-, and five-year term such that in each subsequent year, a vacancy on the Board shall occur and a new Member to the Board of Trustees shall be appointed by the incoming State President. Each year, at their first meeting in June, the Members of the Board of Trustees shall elect a Chairperson of the Board and Recording Secretary from among the Members of the Board.
- **Sec. 4. Vacancies**. Vacancies in the Board shall be filled for the unexpired portion of the term by appointment of the President of the New Jersey State Elks Association.
- **Sec. 5. Meetings.** The Board of Trustees shall meet monthly, at a time and place designated by the Chairperson, and at such other times as deemed necessary by the Chairperson, including electronically. Should any Member of the Board of Trustees absence themselves from any three (3) meetings without sending a communication to the Chairperson or Recording Secretary, noting the reason for absence, or for just cause during the New Jersey State Elks Association Calendar Year (June May), such Member may be removed from the Board by the State President.
 - Three (3) Members of the Board shall constitute a quorum for the transaction of business.
- *Sec. 6. Compensation*. No member of the Board of Trustees shall receive any compensation for their service as Trustee.

ARTICLE 5 – COMMITTEES

Sec. 1. Committees. The State Chairperson may appoint such committees as the members or the State Chairperson may determine shall be advisable to carry out the purposes of the Corporation as set forth in its Certificate of Incorporation.

ARTICLE 6 – Camp Moore Sessions

Sec. 1. Camp Moore Sessions. The Summer Sessions (Sunday – Saturday) will consist of eight weeks of campers between the ages of 7 through 18. The camper must obtain the age of seven (7) to be eligible to attend Camp and cannot exceed the age of Eighteen (18) when attending. There will be one week (Sunday – Saturday) of campers between the ages of 19 through 21. The camper must obtain the age of nineteen (19) to be eligible to attend this session and cannot exceed the age of twenty-one (21) when attending Camp.

The Respite Weekends will consist of six sessions. Three (3) in the Spring and three (3) in the Fall. The Respite Weekends cover Friday through Sunday and the camper must obtain the age of Nineteen (19) to be eligible to attend and all session dates are to be determined, pending the availability of all essential staff members and counselors, and shall be the responsibility of the Board of Trustees.

ARTICLE 7 - SEAL

Sec. 1. Seal. The seal of the Corporation shall be as follows:

ARTICLE 8 -By-Laws

Sec. 1. Revisions. During the fifth year following the adoption of its original By-Laws, or general revision thereof, the Chairperson shall prepare and present a current general revision of the By-Laws to the members for adoption.

Sec. 2 How Amended. These By-Laws may be altered, amended, repealed, or added to by an affirmative vote of a majority of the eligible voting members of the NJSEA present at an Annual Meeting (Wildwood Convention) or (Fall Conference) or at a Special Meeting called for that purpose, provided that a written notice shall have been sent to each member, which notice shall state the alteration, amendments or changes which are proposed to be made in such By-Laws.

ARTICLE 9 – DISSOLUTION

Sec. 1. Dissolution of Corporation. In the event of dissolution of this corporation, the assets shall be distributed only to Charitable or Educational Organizations provided said Organizations enjoy Exempt Status in accordance with provisions of Sec. 501 (c) (3) of the Internal Revenue Code. The New Jersey State Elks Association Charities, Inc. would be the beneficiary of assets if there was a dissolution, and only if this 501 (c)(3) corporation or it successor no longer exists, should the Board of Trustee's look for other 501 (c)(3) organization for distribution. The distribution of the assets of the Corporation shall be the responsibility of the Corporation's Board of Trustees.

Sec. 2 How Amended. These By-Laws may be amended by the following procedure:

1. All proposed amendments are first approved by the Board of Trustees. The proposed amendments shall be voted upon by the Trustees at a regular meeting of the Trustees, provided that each Trustee and each Committee Advisor is given a copy of the proposed Amendment at least 10 days prior to the meeting at which the Amendment is to be discussed and approved. An affirmative vote of at least four of the five Trustees is required for approval.

- 2. A copy of the proposed Amendment is sent to each Voting Member of the Committee and each Committee Advisor, at least 10 days prior to the Meeting at which the vote is to be taken, such vote to be taken at a regular meeting of the Committee. At this meeting the amendment must be approved by a 2/3 vote of the Voting Members eligible to vote.
- 3. Upon approval of the Amendment by the Members of the Committee, it shall be published in the New Jersey Elk for a vote of the New Jersey State Association at either the Annual meeting of the New Jersey State Elks Association or the Fall Conference. At such Annual meeting or Fall Conference, a majority vote of the members present shall be required for approval of the Amendment.

The New Jersey State Hoop Shoot Committee is made up of twelve district directors, four advisors, two regional co-chairs and a chairperson. We have been meeting monthly and will continue to do so until March of next year. Our goal is to run successful, safe and fun Hoop Shoots for kids at the local, district and state level. To that end the committee is always seeking new volunteers to rebound, score and referee.

Each local lodge is required to hold a Hoop Shoot Competition per Grand Lodge statute. These local shoots are underway, and ten of the twelve districts have scheduled their district shoots, which will begin in December and finish in January 2026.

The New Jersey State Hoop Shoot will be on Sunday, February 15, 2026, at South Plainfield High School in South Plainfield, NJ. The shooting times for the individual age groups will be announced closer to the event. The contestants will wear uniforms issued by the committee, Past Grand Lodge Committeeman/Past State President Pete Smith will emcee, a local scout troop will participate in the opening flag ceremony, and the Star-Spangled Banner will be performed live.

The winners of this contest advance to the Regional Competition in Wilkes-Barre, PA, on March 14, 2026; these winners advance to the National contest in Chicago in April of 2026. It's worth noting that New Jersey has sponsored several shooters at the national level in recent years.

I look forward to another successful state Hoop Shoot and thank everyone involved in this valuable program.

The State Soccer Shoot Committee meets once a month from July through March. It is a competition for youth soccer players to test their skills at scoring goals. The contest is broken down by groups of Boys and Girls by age(January 1st, 2025, is the qualifying date). The youngest group are the U8(7 and under age group) they will shoot at the small goals for score. The next groups U10(8- and 9-year-olds), U12 (10- and 11-year-olds), U14(12- and 13-year-olds), U16(14- and 15-year-olds) will shoot at a regulation size goal with a grid attached to score points.

The competition starts at Lodge level, then the winners move on to the district contest in November and December. Those winners will move on to the State contest to be held in Manasquan on January 10th, 2026. The State winner will move on to the Mid Atlantic National Regional in York Pa. on March 7th, 2026.
