# Army of Hope Committee

he NJ State Elks Army of Hope 20th Annual Arthur "RT" Mayer Jr. Golf Outing was held on October 6th at Stanton Ridge Country Club. It was a great day and a fine time was had by all! A special thanks goes out to PDD and Past State AOH Chairperson Brian Murphy for once again doing his usual terrific job organizing the outing.

On Sunday, September 14, 2025, the Army of Hope Committee held its 21st Annual Army of Hope Picnic, "A Day of Remembrance and Patriotism" at Lacey Lodge No. 2518. Over 1,500 members and guests attended, which included 150 Gold Star and severely wounded families and guests, it is hard to put into words the emotions of this day. With the generosity of our lodges, districts and membership, the donations at the end of the day were \$190,000. This is a preliminary accounting report as more donations continue to come in.

Our Sponsor, Past Grand Exalted Ruler Malcolm J. McPherson, Jr. thanked the Army of Hope Committee for all they do. He presented the Army of Hope Committee with a check for \$25,000 from the ENF Special Grant to the New Jersey State Elks Charities Inc.

State President William Dow thanked the Army of Hope Committee for all they have done and continue to do for our Gold Star Families and our severely wounded troops and their families.

The Army of Hope Committee would like to thank all those who came out to volunteer on Saturday morning for the set-up and Sunday for the picnic. A special thank you to the Antlers for your great job of serving our families and their guests. Your respect and courtesy made a lasting impression on them.

Without the fundraisers and donations from our lodges, districts, membership, and ENF, the Army of Hope Committee would not be able to make a difference in so many people's lives. In August we sent out the back-to-school disbursement checks to our Gold Star and severely wounded families in the amount of \$750 per child. In December we will send another \$750 to each child for use during the holidays. Also in December we will send a gift to each of our Gold Star families to help bring some peace to their holidays and remind them that they are always in our thoughts. These three disbursements total \$125,000.



## Requirements for Seeking Elective Office in This Association


Article VI Section 3D - Elections (District Vice President & Trustee)

Section 3: Any Member of this Association may seek an elective office in the Association provided:

(A) They are a Member in good standing in their Lodge and a Past Exalted Ruler.

- (B) Their Lodge is a Member Lodge in good standing in this Association and is located in a District in the electing Region or the District is eligible for the office sought.
- (C) For the position of Vice-President and Trustee, they shall have filed by certified mail, return receipt requested or by email, with the President, their District's Vice President and the Secretary of this Association, not before December 1 and no later than January 5, a Resolution of endorsement adopted by their Lodge, at a regular Lodge session. Said resolution must be signed by the

Lodge Exalted Ruler and **certified** by the Lodge Secretary. If they elect to file by sending an email, it shall only be effective upon receipt of a return email from the President, Secretary and/or Vice President, acknowledging receipt of the Resolution. A local Lodge may only endorse one candidate for the position of Vice President or Trustee.

The Districts which will have Trustee Elections in 2026 are: East, Northeast, South, West Central.



our National Veterans Service Committee has shown remarkable dedication this year by making a significant impact on the lives of veterans. Our members have been instrumental in helping veterans with bills, food, and shelter, ensuring their essential needs are met. Members have participated in Stand Down events by distributing backpacks filled with personal hygiene items, socks, and underwear to veterans living on the streets.

When new facilities open, the committee steps in to provide furniture, creating a comfortable environment for veterans. For those transitioning into housing, we offer Welcome Home kits and furniture, covering everything they need.

There was an open house at NJ State Elk's Veteran's Annex on Sunday, June 1, 2025. It gave Elk members an opportunity to see and hear what we do as a committee. During this special event, we unveiled WCD Vice President, Kevin Storm's mural, Givers of Hope, a tribute to the enduring spirit of generosity and support.

Since January 2025, the committee provided 75 veterans with welcome home kits and deliveries.

Other things we have helped with are:

- Provided hotel stays which totaled \$3,000 to needy veterans.
- 4 air conditioners for a total of \$450.
- •1 cell phone bill for \$310.
- 2 food deliveries for a total of \$300.

The cost of items for welcome home kits and furniture continually goes up. The continuous support from our members has been crucial in enabling these initiatives. Lodges are encouraged to apply for grants to further support veterans with welcome home kits and furniture.

Your dedication to improving veterans' lives is commendable. Thank you for your ongoing support!



#### **Hoop Shoot Committee**

he Hoop Shoot program is one of the key youth activities sponsored by the Elks. It is a basketball free throw contest for boys and girls from the ages 8 to 13. The program has been in existence for over 50 years and over 2 million kids participate annually. Competing in the program encourages kids to set goals, develop effective work habits, learn sportsmanship and have fun.

Competition starts at the local lodge level. Each contest will have 6 winners, a boy and girl in each of the 3 age groups: 8 to 9, 10 to 11 and 12 to 13; they will advance to the District, State, Regional and National competitions. The state competition will be held in February 2026 at South Plainfield High School; the regional competition will be held in March 2026 in Wilkes Barre, PA; and the national finals will be in Chicago, IL, in April 2026. Exact dates will follow. Note that New Jersey has been represented at the national level in each of the last 3 years.

Local lodges and district directors should have received Hoop Shoot packets in the mail in August. This material, along with the Age Calculator, can also be found on the Hoop Shoot dashboard on elks.org.

I encourage directors to educate their volunteers on all rules prior to the contest – parents often know these rules very well. Lodge secretaries need to appoint the lodge Hoop Shoot director in CLMS while local and district contest dates, times, locations and competition winners will be input by the Hoop Shoot directors at those levels.

A few important deadlines: Local shoots must be completed by December 15, 2025, and district competitions should be completed by January 19, 2026.

Please also note that Hoop Shoot is a required program for all lodges per Grand Lodge.

quick reminder that the NJSEA State Museum was re-opened last August and is happily located at Lacey Lodge No. 2518, after relocating from its previous home at New Brunswick Lodge No. 324. Our continued thanks to Lacey for their support and assistance to have the State Museum at their lodge.

In Elks history, mostly at the turn of the 20th century, many lodges sought to remember their absent members by the creation of Elks Rests within local cemeteries, especially for those members whose families could not afford to bury them. Such places are nationally listed at https:// www.elks.org/history/ cemetery.cfm. It was thought there were only three Rests in our state. The Historical Committee has excitedly found at least four more Rests to date and are working to photograph the plots, to





identify those Elks interred, and honor these resting places. Our search for other Rests, if they exist, will continue. Presentation boards of each Rest are being prepared for display in the museum.

The Committee proudly notes that our Past State Presidents video is now on permanent display at the museum. The display chronologically shows our State Presidents, their years of service, their slogans, and their home lodges, as shown in the example picture below. Along with an existing exhibit of NJSEA State Books per year, which also includes pins of the Past Presidents, the Committee is pleased to feature our PSPs within the museum.

The committee pages of NJElks.org were recently updated to reflect the current location of the museum, to show the reopening 2024 event. and to cite the committee's goals. We also retained the earlier pages that featured the New Brunswick museum. All online information and our physical museum exhibits are meant to share the rich history of the NJ State Elks and its charitable projects, programs, and activities throughout the state. In that direction, the Committee is preparing new displays about our State Major Project of Camp Moore with its history and our NJSEA National Veterans Services activities. We always want to encourage members and visitors to the museum and its exhibits, and for those who have already seen the museum, we hope that the refreshing of existing content plus the creating new displays will entice another visit.

ith students returning to classes, that means that our Scholarship Committee gets busy. Below are the various scholarships available:

The 2025 NJ Elks Family Scholarship
application deadline has passed. The Judging Committee has completed its review of the applications and the winners has been contacted.

#### 2025 ENF Scholarship Season

The 2025 Scholarship season is upon us and there are three types of Scholarships offered by Elks National Foundation:

#### 1. The Most Valuable Student Scholarship

Is open to any high school senior who is a citizen of the United States. Ranging from \$1,000 per year to \$12,500 per year, Most Valuable Student scholarships are for students pursuing a four-year degree, on a full-time basis (minimum of 12 semester hours), in a U.S. college or university. Applications will be available online after August 1, 2025 at ELKS.org.

#### 2. The National Legacy Awards Scholarship

Legacy Awards are 44,000 (1,000/yr) scholarships for children and grandchildren of Elks members. The Foundation will offer a total of up to 350 awards in the 2026 contest. New Jersey will receive 10.

The 2026 ENF Legacy Awards contest will kick off on September 1, 2025. Applications for the 2026 contest will be available ONLINE ONLY starting September 1, 2025 at Elks.org. Deadline is February 6, 2026.

#### Who is Eligible?

For the 2026 contest, any child or grandchild (or stepchild, step-grandchild, or legal ward) of a living Elk who joined the order on or before April 1, 2020, or a charter member of a Lodge that was instituted on or after April 1, 2023, is eligible to apply. The Elk must also be a paid-up member through March 31, 2026. Great-grandchildren are not eligible. The applicant must be a high school senior. The applicant must apply online only. The 2026 Legacy Awards application deadline is February 6, 2026. If the applicant's parent and grandparent are both Elk members, the applicant must apply through the parent's Elks Lodge. They have waived the standardized test requirement for the 2026 Legacy contest. You do not need to submit ACT and/or SAT scores. Students may apply for more than one ENF scholarship; however, they may win only one. In cases where the student wins more than one, we will award the scholarship with the greater value. Students can accept local and state scholarships, which are separate from the awards at the national level. Legacy Awards may only be applied to accredited US American schools, colleges or universities. If you are selected as a 2026 Legacy Awards recipient, you will be required to perform service once a year with an Elks Lodge during the four years you are receiving the scholarship. New Jersey will offer 10 Legacy Scholarships this year.

#### North Jersey Elks Developmental **Disabilities Agency**

The North Jersey Elks Developmental Disabilities Agency (NJEDDA) is a private non-profit organization operated by a volunteer Board of Trustees comprised of representatives from several local Elks lodges (Elmwood Park/Paterson, Rutherford, Pompton Lakes, Clifton, Passaic Valley, and Wayne) along with other concerned citizens. NJEDDA was established in 1947 as an elementary school. The agency continued to grow to meet the ever-growing needs of the students and to expand its offering of services to include high school, adult day programming, and a toddler program. The

agency specifically serves children and adults with disabilities. NJEDDA is approved through the New Jersey Department of Education (NJDOE) and New Jersey Division of Developmental Disabilities (NJ DDD) to provide educational and therapeutic services to individuals from the ages of three through adulthood.

The mission of NJEDDA is to advance the independence of the students and clients by enriching their quality of life.



This mission is accomplished through providing opportunities to challenge themselves to learn and grow emotionally and functionally in educational, therapeutic, and vocational environments within an atmosphere of acceptance. The students and clients receive a variety of services which include speech therapy, occupational therapy, physical therapy, counseling, nursing services, and transition services. NJEDDA provides clinics throughout the year to further address the students' and clients' medical, and equipment needs. The collaboration with Children's Specialized Hospital affords the students, along with their families, the opportunity to attend Physiatry clinics. Community plays an important role in the agency. The students and clients are exposed to experiences in the community such as, visiting local libraries, grocery stores, and the post office, which allows them to enhance their skills in communication and mobility.

NJEDDA receives funding through local school districts and the NJ Division of Developmental Disabilities. This funding does not cover the full costs of the desperately needed services of the students and clients served. NJEDDA relies on donations from various outside organizations and individuals such as the Elks National Foundation, Elks State Association, and local Elks lodges. The New Jersey Elks have a long history of service to the community. Through their philanthropic work, they support our agency. We are proud to have the men and women of the Elks supporting our staff to help our students and clients reach their fullest potential and be a part of their communities.
